

General Disclaimer

Thank you for visiting the KAI-KAI FARM'S website and reviewing our Privacy Policy. While visiting, we will not collect any personal information about you unless you choose to provide that information to us. If you choose to provide this information, it will be used for the express purpose for which it was intended, such as responding to your request for information or joining a web discussion forum. We remind you that if you visit a link outside you are subject to the privacy policies of that site.

Information Collected and Stored Automatically

KAI-KAI FARM automatically collects some technical information from you when you visit the site in order to give you the best possible experience. KAI-KAI FARM uses web measurement technology (Google Analytics) to automatically track how visitors interact with KAI-KAI FARM including where they came from, what they did on the site and whether they completed any pre-determined tasks while on the site. Aggregate data is used to help KAI-KAI LLC improve our user interface and diversify our content offerings to meet the needs of our customers, track operational problems, prevent fraud and improve the effectiveness, security and integrity of the site. This information does not identify you personally and data is only retained in accordance with the KAI-KAI LLC data retention policy. For each page that you visit, we collect and store only the following technical information:

- Date and time of access

- URL address of the KAI-KAI FARM webpage visited

- Internet domain and IP address from which our website was accessed

- Type of browser and operating system used to access our site (if provided by the browser)

- URL address of the referring page (if provided by the browser)

- Completion or success status of the request for a web page or other on-line item

- File size of the webpage visited

This information is only used to help us make the site more useful for you. With this data we learn about the number of visitors to our site and the types of technology our visitors use. We never track or record information about individuals and their visits and we do not share this data with anyone outside the KAI-KAI LLC unless necessary for law enforcement purposes.

Cookies

When you visit some websites, their web servers generate pieces of information known as cookies, which helps webmasters understand how users interact with their site's content and services. Websites use cookies to track one's activities on a website (e.g., pages visited, links clicked on, etc.), and to record information about the user so when the user returns to the site, customized features can be provided.

There are two types of cookies. A session cookie is a line of text that is stored temporarily in your web browser's memory cache, and will expire when the browser is closed. A session cookie is not placed on any hard drive, and it is destroyed as soon as you close your browser. A persistent cookie is saved to a file on your hard drive and is accessed whenever you re-visit the website that put it there. This lets that website remember what you were interested in the last time you visited.

We use persistent cookies to enable Google Analytics to differentiate between new and returning KAI-KAI FARM visitors. Persistent cookies remain on your computer between visits to KAI-KAI FARM until they expire. We also use persistent cookies to block repeated invitations to take the customer satisfaction survey. The persistent cookies that block repeated survey invitations expire in 90 days.

KAI-KAI FARM may utilize third party services to enhance its distribution of data and information (e.g., videos) through links from the KAI-KAI FARM web site. A persistent cookie may be set by such a third party provider when you click on the provider's link in order to KAI-KAI FARM data (e.g., play a video).

By default, persistent cookies and web measurement technologies are automatically used when you visit KAI-KAI FARM. Nevertheless, if you decide to disable or remove cookies from your browser, you will continue to have access to all information and resources on KAI-KAI FARM.

Information Collected from Interactive Forms and Surveys

KAI-KAI FARM provides interactive forms that let you voluntarily submit personal information (such as your e-mail address, name, or organization). This occurs when you register to join an online community to submit information to web discussion forums, blogs and other community features; registering to receive e-mail updates and newsletters; and sending questions and comments to the KAI-KAI FARM team. In these cases, all submitted information is used only for the express purposes for which it is provided, and is not made available to any third party.

KAI-KAI FARM only shares information to the extent necessary to complete purchase transactions with our ecommerce partners. KAI-KAI FARM never collects information or creates individual profiles for third-party commercial marketing. However, when you join an online community and participate in online discussions, your name and other personal information you provide (except e-mail) are viewable by anyone visiting KAI-KAI FARM, unless you choose not share this information with the public on your user profile page. Any personal information you provide will be protected to the extent permissible under the Privacy Act.

Electronically submitted information is maintained and destroyed on an as-needed basis.

KAI-KAI LLC may also use online survey instruments to obtain feedback on your experience with KAI-KAI FARM. The survey initiation pops up for a random sample of visitors, is voluntary and does not collect personal information. If you decline the survey you will still have access to the same information and resources of KAI-KAI FARM as those who do take the survey. The survey reports are available only to KAI-KAI FARM managers and other staff who require this information to perform their duties. The KAI-KAI LLC retains the data from the survey results in accordance with its data retention policy.

Children's Privacy

Because we care about the safety and privacy of children online, we comply with the Children's Online Privacy Protection Act of 1998 (COPPA). COPPA and its accompanying regulations protect the privacy of children using the Internet. KAI-KAI FARM does not knowingly contact or collect personal information from children under 13. KAI-KAI FARM is not intended to solicit information of any kind from children under 13.

It is possible that by fraud or deception we may receive information pertaining to children under 13. If we are notified of this, as soon as we verify the information, we will immediately obtain parental

Site Security
